- viii. Jwettaq analiżi, jikteb rapporti u jhejji sottomissjonijiet orali u bil-miktub meħtieġa fil-qasam tax-xogħol.
- ix. Jikkoordina l-laqgħat tal-Kumitat Legali u jikkompila rapporti dwar id-deċiżjonijiet tiegħu.
- x. Isegwi u jipproċessa talbiet għall-assistenza reċiproka fl-irkupru ta' taxxi dovuti f'pajjiżi oħra tal-UE u jiffirma ittri ġudizzjarji relatati mal-ġbir ta' djun fiskali.
- xi. Imexxi u jikkoordina ix-xogħol ta' uffiċjali legali oħra fi ħdan l-Uffiċċju tal-Kummissarju għat-Taxxi;
- xii. Jorganizza/jassisti fit-taħriġ tal-impjegati tas-CfR dwar kwistjonijiet fiskali;
- xiii. Jikkollabora mal-Uffiċċju tal-Avukat Ġenerali, il-Kummissarju tal-Pulizija u l-Uffiċċju tal-Ombudsman u jikkoordina mas-sezzjonijiet legali f'dipartimenti u entitajiet oħra tal-gvern kif meħtieġ;
- xiv. Dmirijiet oħra kif ikun meħtieġ mis-superjur/i tiegħu;
- xv. Jaqdi dmirijiet omir skont l-eżiġenzi tas-Servizz Pubbliku skont struzzjonijiet mogħtija mis-Segretarju Permanenti Ewlieni;

Duties and responsibilities

- i. Acts as the principal legal adviser within the Office of the Commissioner for Revenue with reference to income tax matters and manages the Legal Unit within the said Office.
- ii. Re-engineers processes, where necessary, in order to ensure an effective and efficient legal service.
- iii. Represents the Commissioner for Revenue before the Law Courts and Tribunals in Malta and Gozo with reference to income tax matters and prepare all necessary documentation.
- iv. Provides advice to the Commissioner for Revenue on legal/technical income tax issues.
- v. Gives technical opinions on legal tax issues to taxpayers and/or their representatives.
- vi. Assists in the drafting and coordination of amendments to the Income Tax Acts and the Commissioner for Revenue Act, including subsidiary legislation.
- vii. Keeps abreast of current affairs and judgements and suggests necessary amendments.
- viii. Effects research on tax matters, carries out analysis, writes reports and prepares oral and written submissions necessary in the field of work.
- ix. Co-ordinates the Legal Committee meetings and compiles reports on its decisions.
- x. Follows and processes requests for mutual assistance in the recovery of taxes due in other EU countries and signs judicial letters related to the collection of tax debts.
- xi. Manages and coordinates the work of other legal officers within the Office of the Commissioner for Revenue;
- xii. Organises/assists in the training CfR staff on tax matters;
- xiii. Liaises with the Office of the Attorney General, the Commissioner of Police and the Office of the Ombudsman and co-ordinates with legal units in other government Departments and entities as necessary;
- xiv. Undertakes any other tasks, which the superior/s may delegate to him/her, as may be required
- xv. Any other duties according to the exigencies of the Service as directed by the Principal Permanent Secretary.
