B'REFERENZA għan-Notifikazzjoni tal-Gvern Nru. 965, ippubblikata fil-Gazzetta tal-Gvern Nru. 19,314 tat-23 ta' Settembru, 2014, l-artikolu 4 tal-iskema ta' għotja 'Funerali' qed jiġi emendat biex jinkludi l-klawsola li ġejja.

Fid-dawl tat-tifqigħa COVID-19, f'kazijiet fejn il-quddiesa tal-funeral u d-difna ma jsirux fl-istess data (bil-quddiesa ssir f'data li tiġi wara dik tad-difna), applikazzjoniet taħt din l-iskema, inklużi d-dettalji tad-dokumenti meħtieġa, għandhom isiru sa mhux aktar tard minn sitt xhur (180 gurnata) mid-data tal-quddiesa tal-funeral. AND FINANCIAL SERVICES****Funerals Grant**

WITH reference to Government Notice No. 965, published in Government Gazette No. 19,314 of the 23rd September, 2014, article 4 of the grant scheme 'Funerals' is being amended to include the following clause.

In view of the COVID-19 outbreak, in cases where the funeral mass and the burial are not held on the same date (i.e. the funeral mass is held on a date following the date of the burial), applications under this scheme, including the details of documents required, should be submitted by not later than six months (180 days) from the date of the funeral mass. Applications received 'late', that is after the six-month period, shall be deemed to be invalid applications.

All the other articles and applicable conditions under the grant scheme issued in terms of Government Notice No. 965, published in Government Gazette No. 19,314 of the 23rd September, 2014 shall be kept in force within their terms and conditions and shall continue to be effective and binding.

This amendment will be in force for a temporary period until the Minister for Finance and Financial Services indicates otherwise.
