Bord ta' Reviżjoni dwar Kuntratti Pubbliċi

Re: MFED746/2021 - Open Call/ Negotiated Procedure for the Provision of Cleaning Services in State Schools and Educational Facilities (including Summer) in Malta and Gozo using Environmentally Friendly Products

Risposta tal-Ministeru għall-Edukazzjoni għall-oġġezzjoni mressqa minn E.C Municipals Limited (C62598) kif dedotta fl-ittra tagħha tat-3 ta' Dicembru 2021, fil-konfront tal-process fuq citat.

#### Fatti

Illi fit-22 ta' Novembru 2021, il-Ministeru għall-Edukazzjoni ("il-Ministeru") talab l-approvazzjoni tad-Dipartiment tal-Kuntratti ("DOC") ai termini tar-Regolament 154(1)(c) tal-Regolamenti dwar l-Akkwist Pubbliku sabiex tinfexx procedura negozjata minghajr pubblikazzjoni "*for the Provision of Cleaning Services in State Schools and Educational Facilities (including Summer) in Malta and Gozo using Environmentally Friendly Products*" (liema talba għall-approvazzjoni hija hawnhekk mehmuzha u mmarkata bhala 'Dok. MFED1'). *In buona fede*, kif jirrizulta mid-Dok. MFED1, il-Ministeru ma talabx l-approvazzjoni tad-DOC sabiex javvicina u jinneogzja ma operatur specifiku/operaturi specifiċi, izda talab l-approvazzjoni tad-DOC sabiex il-procedura negozjata ssehh b'mod illi kull min hu interessat u eligibbli jkun jista' jippartecipa fiha [vide 'Dok. MFED1' u s-sejha Dok. "A" mehmuzha mal-oġġezzjoni mressqa minn E.C Municipals Limited].

ta' Dicembru 2021.

Dwar l-aggravji mressqa minn E.C Municipals Limited kif dedotti fl-ittra taghha tat-3 ta' Dicembru 2021

Illi fl-ewwel lok irid jigi rilevat illi fl-ewwel paragrafu tal-oggezzjoni taghha tat-3 ta' Dicembru 2021, E.C. Municipals Ltd tiddikjara illi "**Dan l-appell qieghed isir b'riferenza ghal-lot numru 11** izda l-aggravji li ser jigu sollevati huma applikabbli ghal-lots kollha u ghas-sejha in generali." B'hekk jidher li E.C. Municipals Ltd qieghda tiddikkjara illi l-appell taghha huwa fir-rigward ta' lot numru 11 biss u li l-interess guridiku taghha huwa limitat ghal dan il-lot numru 11 biss u ghaldaqstant, bir-rispett, dan il-Bord ta' revizjoni ghandu jitratta l-oggezzjoni mertu ta' dawn il-proceduri f'dan l-isfond.

B'hekk, bir-rispett, ghandu jirrizuta immedjatament illi l-imsemmija oggezzjoni tal-E.C. Municipals Ltd hi totalment infondata hu ghandha tigi respinta.

Municipals Ltd. L-imsemmi Regolament 154(1)(c) tal-L.S 601.03 jeskdudi

espressament l-applikabbilta' tat-termini relattivi ghal proceduri miftuha jew ristretti jew kompetittivi bin-negozjar. L-istess regolament 154(1)(c) fil-fatt itenni espressament illi l-stess regolament huwa applikabbli propju meta "il-limiti ta' zmien ghal proceduri miftuha jew ristretti jew kompetittivi bin-negozjar ma jistghux jigu rispettati".

Illi b'hekk il-Ministeru ma kienx marbut b'terminu minimu ta' hamsa u tletin jum ghall-ircevuta tal-offerti kif allegat minn E.C. Municipals Ltd u t-terminu ta' ghaxart' ijiem moghti mill-Ministeru kien skond il-ligi.



MFED is requesting to issue this open call/negotiated procedure (traditional mode) since an approved DOC negotiated procedure with Brightness JV will expire on the 31<sup>st</sup> December 2021 and a tender for cleaning state schools is still on the market and requires to be evaluated.
