We would like to object the decision related to the SPD7/2021/050: Tender for the Provision of Health and Life Insurance Policies for the Malta Business Registry for **Lot 2: Group Life Insurance only**.

It seems that the contract is being awarded on the basis of a Quotation Ref No. 162739 identical to the one submitted by Antes Insurance Brokers Ltd (ID Tender 162743) which was considered as not technically compliant.

Thus, how can a quotation from Antes Insurance Brokers Ltd be considered as non-compliant but the quotation for AIB Insurance Brokers Ltd is considered complaint. We feel that the cheapest compliant offer is that of Antes Insurance Broker Ltd with ID Tender Ref No. 162736.
