**Għotja dwar Tiġijiet/Ċerimonji ta' Unjonijiet Ċivili**

B'REFERENZA għan-Notifikazzjoni tal-Gvern Nru. 7, ippublikata fil-Gazzetta tal-Gvern Nru. 20,113 tal-4 ta' Jannar, 2019, l-artikolu 4 tal-iskema ta' għotja 'Tiġijiet/Ċerimonji ta' Unjonijiet Ċivili' qed jiġi emendat biex jinkludi l-klaqsola li ġejja.

Fid-dawl tat-tifqigha COVID-19, f'każijiet fejn iċ-ċeremonja taż-żwieġ/unjoni ċivili u r-riċeviment tat-tieġ ma jsirux fl-istess data (bir-riċeviment isir f'data li tiġi wara dik taċ-ċeremonja), applikazzjoniet taħt din l-iskema, inkluži d-dettalji tad-dokumenti meħtieġa, għandhom isiru sa mhux aktar tard minn sitt xhur (180 ġurnata) mid-data tar-riċeviment taż-żwieġ/taċ-ċeremonja tal-unjoni ċivili. Applikazzjonijiet milqugħha 'tard', jiġifieri wara dawn is-sitt xhur jiġi kkunsidrati bħala applikazzjonijiet invalidi.

L-artikoli l-oħra kollha u l-kundizzjonijiet applikabbli taħt l-iskema ta' għotja mahṛuġa skont in-Notifikazzjoni tal-Gvern Nru. 7, ippublikata fil-Gazzetta tal-Gvern Nru. 20,113 tal-4 ta' Jannar, 2019, se jibqgħu fis-seħħ fit-termini u l-kundizzjonijiet tagħhom u jibqgħu jkunu effettivi u vinkolanti.

Din l-emenda se tkun fis-seħħ għal perjodu temporanju sakemm il-Ministru għall-Finanzi u s-Servizzi Finanzjarji jindika mod ieħor.

**Weddings/Civil Union Ceremonies Grant**

WITH reference to Government Notice No. 7, published in Government Gazette No. 20,113 of the 4th January, 2019, article 4 of the grant scheme 'Weddings/Civil Union Ceremonies' is being amended to include the following clause.

In view of the COVID-19 outbreak, in cases where the marriage/civil union ceremony and the wedding reception are not held on the same date (i.e. the reception is held on a date following the date of the ceremony), applications under this scheme, including the details of documents required, should be submitted by not later than six months (180 days) from the date of the wedding/civil union reception. Applications received 'late', that is after the six-month period, shall be deemed to be invalid applications.

All the other articles and applicable conditions under the grant scheme issued in terms of Government Notice No. 7, published in Government Gazette No. 20,113 of the 4th January, 2019, shall be kept in force within their terms and conditions and shall continue to be effective and binding,

This amendment will be in force for a temporary period until the Minister for Finance and Financial Services indicates otherwise.
